General Terms

THIS AGREEMENT TO TERMS & CONDITIONS (herein after referred to as the "Agreement") is made and entered into on receiving and completing the membership application, and submitting the amount of dollars per agreed membership fee.

1. TERMINOLOGY

Hereinafter, in these terms and conditions, the expressions "WoW" are a reference to Women of Weddings. The term "Member" is used in reference to Members of Women of Weddings.

WoW comprises businesses in or related to the Wedding industry in Victoria, British Columbia, as well as in communities on Vancouver Island. WoW reserves the right to add or remove businesses to WoW at its discretion. WoW may, at its discretion, permit limited numbers of members from each business category, profession or franchise to become members. Members agree to engage with other members and guests in a respectful manner. Contact details supplied by other members and guests are to be used solely for the purpose of professional networking. Members must not intimidate, molest, harass or otherwise interfere with other members. In the event that a member intimidates, molests, harasses or otherwise interferes with another member, WoW, at its sole discretion, may terminate that member's membership. WoW reserves the right to terminate a member's membership at its discretion, for instance, in the event of a member being convicted of a serious offence or being declared bankrupt. WoW is the only entity to represent WoW in any relationship with the public and via the media. Each member agrees not to take any action or make any claim against WoW. Each member will indemnify WoW against any liability for any statement or action a member may make or takes that result in liability for WoW. Policies are subject to change at any time. Memberships may be terminated or revoked at any time at the discretion of WoW for the failure of members to comply with its Terms and Conditions.

1. MEMBERSHIP FEES

Fees are not refundable for memberships, advertising fees or sponsorship fees, or any other WoW events or activities. Fees are not transferrable unless the fees are transferred to another member of the member's business or company. The initial term of this Agreement shall be for the term of one (1) year (the "Initial Term"). At the expiration of the Initial Term, this Agreement will automatically renew for a one (1) year period (each a "Renewal Term" and collectively with the Initial Term the "Term") unless a party provides the other parties with notice of its intent not to renew this Agreement at least ninety (90) days prior to the expiration of the then current term.

2. CANCELLATIONS AND ALTERATIONS OF WOW EVENTS

WoW reserves the right to alter, change or cancel an event at any time. In the event that an event is altered, changed or cancelled, members and guests booked for the WoW Event will be advised as soon as possible. Cancellation of bookings for the event will only be accepted 5 working days prior to the WoW Event. If a member chooses to cancel within 5 working days of the event, it is expected that the member will make every effort to send another participant in their place.

3. ATTENDING WOW EVENTS

WoW will endeavour to hold monthly meetings in the form of WoW Events. Each WoW Event will be of approximately 2 hours duration. Members will be expected to arrive at the WoW Event on time and be in attendance at the WoW Event for its entire duration. WoW will provide an area at each of its WoW Events for Showcase Sponsors Only to display their business cards, brochures and promotional material. WoW reserves the right to remove any business cards, brochures, promotional material, papers or any other materials displayed at the WoW Event which it deems to be inappropriate or offensive. Children are not permitted to attend at any WoW events.

4. PRIVACY POLICY

WoW will collect personal information about Members. Our primary purpose in collecting this personal information is to enable Women of Weddings to provide services to Members. WoW require this information for the purposes listed below and if a Member chose not to provide the information requested, WoW may not be able to provide services to the Member. This information may be used for related purposes such as to assist in providing goods and services to the Member, to assist with any enquiries the Member makes to WoW, for any purpose made known to the Member at the time of collection of the Member personal information, to communicate promotional offers, business referrals and special events, for our internal administrative, marketing, planning, product development and research requirement in connection with law enforcement, national security and airport surveillance and in relation to business referral program. WoW usually discloses information of this kind to, third parties such as consultants, auditors, legal advisors and the like, third parties WoW are required to disclose to. Under privacy principles, the Member may access personal information held by WoW. The Member may also be contacted by sponsors from time to time. In accepting membership in WoW the member is deemed to have consented to the privacy policy as described above. WoW reserves the right to utilize any images taken at WoW Events for commercial or portfolio purposes.
